| Context

GDPR is applicable since the 25th of May 2018, 2 years after its adoption on 24th May 2016.

This new regulation creates a **directly applicable regulatory framework (no national law needed) that unifies the data protection laws of the 28 EU countries**, and replace the previous Data Protection directive (95/46/CE).

Furthermore **Switzerland** has decided to update its own data protection law to keep adequacy with the GDPR.

It is therefore a **unique compliance challenge** that all Swiss organisations and enterprises will face in order to avoid/mitigate reputational, financial and operational risks that may arise from European regulators, Swiss data protection commissioner or legal actions.

Swiss organisations that offers goods or services to data subjects in the Union, irrespective of whether a payment of the data subject is required, or monitor their behaviour as far as their behaviour takes place within the Union, are concerned by the GDPR.
